Whereas, a violent attack targeting Israeli Citizens occurred on Saturday October 7th, 2023;
Whereas, the army of Russia continues its illegal actions against the citizens of Ukraine; and
Whereas, these horrific actions have included the killing of children and the kidnapping of innocent bystanders.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of Vernon Township, Lake County, Illinois, as follows:

Section 1. The statements set forth in the preamble hereto are adopted as the findings of the Township Board, as if fully set forth herein.

Section 2. The Vernon Township Board of Trustees:

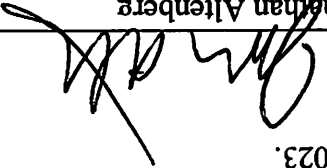
1. Condemn unequivocally the appalling attacks by terrorists against the innocent civilians of Israel and the continued illegal invasion of Russian troops against the people Ukraine;
2. Stand in solidarity with the people of Israel and Ukraine and extend our condolences for the lives lost in these attacks;
3. Support the governments of both Israel and Ukraine to defend themselves and actively protect the lives of their citizens;
4. Urge the World community to stand up in solidarity with these nations and demand the immediate release of hostages taken in these actions; and
5. Stand in solidarity with the people of Israel and extends our condolences for the Israeli lives lost in these attacks.

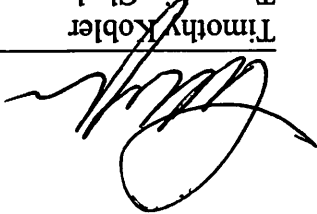
Section 3: This Resolution shall be in full force and effect upon its adoption.
